

# FAQ FOR SCHOLARSHIPS

## ***Membership Dues Scholarships with option of 3 lunch reimbursements:***

Who is able to apply?

- Any new member joining AFP since January 2018. Criteria is eligibility for membership.

Are consultants able to apply?

- Yes, as long as they meet the criteria for membership.

How does the scholarship work?

- It is a reimbursement scholarship which means you must have applied and paid your membership dues before you will receive your reimbursement.

How do the lunch reimbursements work?

- On the application, you will have the opportunity to note that you are interested in receiving up to three lunch reimbursements. Reimbursements are 50% of the cost of the lunch (or \$10 each lunch). Because it is a reimbursement, you will need to register and pay before you receive the reimbursement. Your lunch reimbursements are only valid during 2018.

Do I have to take the lunch reimbursements?

- No, you will be able to choose to take advantage of them if you would like to, but there is no requirement.

Do I have any requirements for accepting the scholarship?

- Yes, there is a requirement to serve on a committee for a one year period.

Who do I go to with questions?

- Please direct questions to the Scholarship Committee member listed on the application.

### ***Fundraising Fundamentals Scholarships:***

Who is able to apply?

- Any current member of the Central Ohio AFP chapter. The committee will consider a number of criteria to balance applicant's need and involvement in the chapter.

Are consultants able to apply?

- Yes.

How does the scholarship work?

- If you are awarded a scholarship, you will receive a special link to register for the course for free. This is not a reimbursement.

Can I apply for other scholarships when I apply for this scholarship?

- Yes.

Do I have any requirements for accepting the scholarship?

- Yes, you are expected to follow through on taking the course, and there is a requirement to serve on a committee or the board for a one year period.

Who do I go to with questions?

- Please direct questions to the Scholarship Committee member listed on the application.

### ***CFRE Application/Exam Fee Scholarships:***

Who is able to apply?

- Any current member of the Central Ohio AFP chapter who meets the criteria of a CFRE. The committee will consider a number of criteria to balance applicant's need and involvement in the chapter.

Are consultants able to apply?

- Yes.

How does the scholarship work?

- This is a reimbursement scholarship of 50% of the application/exam fee plus the administrative fee (\$365), and you will show that you have registered and taken the exam before being reimbursed.

Do I have to take the exam in 2018 to receive the reimbursement?

- Yes.

Do I have to pass the exam to receive the reimbursement?

- No.

Can I apply for this scholarship to cover application fees for renewals or a subsequent attempt to pass the exam?

- This scholarship does not cover renewal application fees.
- You may apply for the scholarship if you are working on your initial certification.

Can I apply for other scholarships when I apply for this scholarship?

- Yes.

Do I have any requirements for accepting the scholarship?

- Yes, there is a requirement to serve on a committee or the board for a one year period.

I am a consultant. Who should write my recommendation letter?

- A principal from your consulting firm, a client, an AFP Board member, or the chair of the AFP committee you are serving on.

Who do I go to with questions?

- Please direct questions to the Scholarship Committee member listed on the application.

### ***AFP International Conference Scholarships:***

Who is able to apply?

- Any current member of the Central Ohio AFP chapter who meets the criteria of the individual scholarship applicant is applying for (Chamberlaine, Emerging

Scholar and Attendance). The committee will consider a number of criteria to balance applicant's need and involvement in the chapter. You may not apply for this scholarship if you have received a scholarship to the AFP International Conference in the last three years prior to the year in which you are applying.

Are consultants able to apply?

- Yes.

How does the scholarship work?

- This is a reimbursement scholarship, and you will be reimbursed for expenses by submitting proof of the expenditures. The Chamberlain Scholar receives a specially designated link for registration.

Can I apply for other scholarships when I apply for this scholarship?

- Yes, however, the committee will take into consideration if you have received an AFP International Conference scholarship in the past.

Do I have any requirements for accepting the scholarship?

- Yes, there is a requirement to serve on a committee or the board for a one year period and to share the impact of attending the conference at a monthly lunch or December annual meeting.

I am a consultant. Who should write my recommendation letter?

- A principal from your consulting firm, a client, an AFP Board member or the chair of the AFP committee you are serving on.

Who do I go to with questions?

- Please direct questions to the Scholarship Committee member listed on the application.

### ***Other Educational Opportunities Scholarships:***

Who is able to apply?

- Any current member of the Central Ohio AFP.

Are consultants able to apply?

- Yes.

How does the scholarship work?

- This is a reimbursement scholarship, and you will be reimbursed for 50% of the registration fee up to \$400 by providing proof of registration. You are expected to attend the session. There is no reimbursement for any other sort of fees or expenses associated with the course.

Which courses qualify?

- The committee will not be vetting the educational courses you are proposing. You may apply for this scholarship to attend a session put on by AFP, COPGC/PPP, CASE, University of Indiana School of Fundraising, and the Association for Healthcare Philanthropy. As part of the application, you will provide a link to information or the course brochure.

Can I apply for other scholarships when I apply for this scholarship?

- Yes, however, the committee will take into consideration other scholarships you have received in the past.

Do I have any requirements for accepting the scholarship?

- Yes, there is a requirement to serve on a committee or the board for a one year period.

I am a consultant. Who should write my recommendation letter?

- A principal from your consulting firm, a client, an AFP Board member or the chair of the AFP committee you are serving on.
